

**3.2 The FPO shall:**

- Provide field facilities and necessary support for student internships and training.

- Bear local hospitality and logistics for programmes held at village level.

**4. DURATION**

This MOU shall be valid for a period of **three (3) years** from the date of signing and may be renewed by mutual consent.

**5. FINANCIAL ARRANGEMENT**

This MOU does not involve any financial commitment from either party. Specific projects may be taken up jointly under government schemes as and when required.

**6. TERMINATION**
